MARILYN AQUINO NAMED CHIEF RISK OFFICER

Hong Kong, 24 August, 2016 – First Pacific Company Limited (HKSE: 00142) (“First Pacific” or the “Company”) today named Marilyn A. Victorio-Aquino as Chief Risk Officer effective immediately.

As CRO, Ms. Aquino’s role is to understand, develop, review and monitor the Enterprise Risk Management processes – including identification of the key enterprise risks and the corresponding mitigation measures – across First Pacific’s major operating units. Ms. Aquino was a partner at SyCip Salazar Hernandez & Gatmaitan, the largest full-service law firm in the Philippines, prior to joining First Pacific.

She graduated cum laude (and was class salutatorian) from the University of the Philippines College of Law and placed second in the nationwide Philippine Bar Examination. Ms. Aquino is a member of the International Pacific Bar Association, the Women Lawyers Circle, Fideracion Internacional de Abogadas, the Philippine Bar Association and the Integrated Bar of the Philippines.
