### **Indofood financial results for the period ended 30 September 2020**

The attached press release was released today in Jakarta by PT Indofood Sukses Makmur Tbk (“Indofood”, IDX: INDF), in which First Pacific Group holds an economic interest of 50.1%.

Indofood is a leading Total Food Solutions company with operations in all stages of food manufacturing from the production of raw materials and their processing through to the manufacture of consumer food and beverage products and their distribution to the market. It is based and listed in Indonesia while its Consumer Branded Products subsidiary PT Indofood CBP Sukses Makmur Tbk and Agribusiness subsidiaries PT Salim Ivomas Pratama Tbk and PT Perusahaan Perkebunan London Sumatra Indonesia Tbk are also listed in Indonesia. Another subsidiary, Indofood Agri Resources Ltd., is listed in Singapore, and an Agribusiness associate, Roxas Holdings, Inc., is listed in the Philippines. Through its four complementary Strategic Business groups, Indofood manufactures and distributes a wide range of food and beverage products: Consumer Branded Products (noodles, dairy, snack foods, food seasonings, nutrition & special foods, and beverages), Bogasari (wheat flour and pasta), Agribusiness (seed breeding, oil palm cultivation and milling, branded cooking oils, margarine and shortening, cultivates and processes of rubber, sugar cane and other crops) and Distribution.

Indofood is one of the world’s largest manufacturers by volume of wheat-based instant noodles, one of the largest plantation companies by area and the largest flour miller in Indonesia. Indofood also has an extensive distribution network across Indonesia.

**INDOFOOD FINANCIAL RESULTS FOR THE PERIOD ENDED 30 SEPTEMBER 2020**

- Consolidated net sales increased 2% to Rp58.78 trillion
- Income from operations increased 21% to Rp8.63 trillion
- Core profit increased 26% to Rp4.34 trillion

**Jakarta, 30 November 2020** – PT Indofood Sukses Makmur Tbk (“Indofood” or the “Company”) today announced its financial results for the period ended 30 September 2020. The Company posted a 2% growth in consolidated net sales to Rp58.78 trillion from Rp57.85 trillion last year.

Income from operations increased 21% to Rp8.63 trillion from Rp7.15 trillion, and operating margin increased to 14.7% from 12.4%. Income for the period attributable to equity holders of the parent entity grew 6% to Rp3.75 trillion from Rp3.53 trillion, and net income margin improved to 6.4% from 6.1%. Core profit increased 26% to Rp4.34 trillion from Rp3.44 trillion.

Anthoni Salim, the President Director and Chief Executive Officer of Indofood, said: “In the midst of continuous global challenges, our resilient business model allows us to deliver consistent growth and increased results in the nine-month period of 2020. We will consistently strive to serve our customers and aim to exceed their expectations, whilst safeguarding our people.”
