## INDOFOOD FINANCIAL RESULTS FOR THE PERIOD ENDED 30 JUNE 2024

- Consolidated net sales increased 2% to Rp57.30 trillion
- Income from operations increased 33% to Rp11.75 trillion
- Core profit increased 22% to Rp5.67 trillion

**Jakarta, 31 July 2024** – PT Indofood Sukses Makmur Tbk (“Indofood” or the “Company”) today announced its financial results for the period ended 30 June 2024. The Company posted a 2% growth in consolidated net sales to Rp57.30 trillion from Rp56.09 trillion in the same period last year.

Income from operations increased 33% to Rp11.75 trillion from Rp8.86 trillion, and operating margin remained healthy at 20.5%. Core profit, which reflects the underlying operating performance of the Company, increased 22% to Rp5.67 trillion from Rp4.66 trillion in the first semester last year.

Anthoni Salim, the President Director and Chief Executive Officer of Indofood, said: “Indofood has been able to record consistent positive performance in the first half of 2024. Nevertheless, we are cautiously optimistic amid global uncertainties, while still maintaining a strong balance sheet and balancing between market share and profitability.”
