DISPOSAL OF 50% INDIRECT INTEREST IN PHILIPPINE COASTAL STORAGE & PIPELINE CORPORATION BY METRO PACIFIC INVESTMENTS CORPORATION

Reference is made to the announcement of First Pacific Company Limited (the “**Company**”) dated 23 October 2024 in relation to the disposal of 50% indirect interest in PCSPC by MPIC (the “**23 October Announcement**”). Capitalised terms used in this announcement shall have the same meanings as defined in the 23 October Announcement.

This announcement is made to provide supplemental information on the relationship among the counterparties to the transaction, being the Purchaser, Terminal PH Investments Pte. Ltd., and ISQ.

As disclosed in the 23 October Announcement, the Purchaser is a wholly owned subsidiary of Terminal PH Investments Pte. Ltd.. Both the Purchaser and Terminal PH Investments Pte. Ltd. are portfolio companies of ISQ Growth Markets Infrastructure Fund, an investment fund managed by ISQ. ISQ Growth Markets Infrastructure Fund has funds registered with and regulated by the Cayman Islands Monetary Authority (CIMA), and has over 15 unique limited partners headquartered across nine countries.

All information set out in the 23 October Announcement remains unchanged. This announcement is supplemental to and should be read in conjunction with the 23 October Announcement.
