Non-registered Shareholders who wish to appoint proxy(ies) to attend and vote in their stead at the SGM, please consult directly with their banks or brokers or custodians or nominees (as the case may be) to assist them in the appointment of proxy(ies).

Please note that there will be no serving of food nor drinks to the attendees of the SGM.
