Indofood's financial results for the period ended 30 September 2025

The attached press release was released today in Jakarta by PT Indofood Sukses Makmur Tbk ("Indofood", IDX: INDF), in which First Pacific Group holds an economic interest of approximately 50.1%.

Indofood is a leading Total Food Solutions company with operations in all stages of food manufacturing, from the production of raw materials and their processing, to consumer products and their distribution to the market. It is based and listed in Indonesia while its Consumer Branded Products subsidiary PT Indofood CBP Sukses Makmur Tbk and Agribusiness subsidiaries PT Salim Ivomas Pratama Tbk and PT Perusahaan Perkebunan London Sumatra Indonesia Tbk are also listed in Indonesia. Another subsidiary, Indofood Agri Resources Ltd., is listed in Singapore.

Indofood capitalizes on economies of scale and a resilient business model, manufactures and distributes a wide range of food and beverage products from its four complementary Strategic Business groups: Consumer Branded Products (noodles, dairy, snack foods, food seasonings, nutrition & special foods, and beverages), Bogasari (wheat flour and pasta), Agribusiness (seed breeding, oil palm cultivation and milling, branded cooking oils, margarine and shortening, and the cultivation and processing of sugar cane, rubber, and other crops), and Distribution.

Indofood is one of the world's largest manufacturers by volume of wheat-based instant noodles, one of the largest plantation companies by area and the largest flour miller in Indonesia. Indofood also has the most extensive distribution network in Indonesia.

INDOFOOD FINANCIAL RESULTS FOR THE PERIOD ENDED 30 SEPTEMBER 2025

- Consolidated net sales increased 5% to Rp90.98 trillion
- Income from operations increased 12% to Rp18.10 trillion
- Core profit grew 1% to Rp8.42 trillion

Jakarta, 31 October 2025 – PT Indofood Sukses Makmur Tbk (“Indofood” or the “Company”) today announced its financial results for the period ended 30 September 2025. The Company posted a 5% growth in consolidated net sales to Rp90.98 trillion from Rp86.94 trillion in the same period last year.

Income from operations increased 12% to Rp18.10 trillion from Rp16.09 trillion, and operating margin improved to 19.9% from 18.5% last year. Income for the period attributable to equity holders of the parent entity decreased 10% to Rp7.88 trillion from Rp8.76 trillion in the same period last year, mainly due to the depreciation of Rupiah resulting in unrealized foreign exchange losses from financing activities. Core profit, which reflects the underlying operating performance of the Company, increased 1% to Rp8.42 trillion from Rp8.30 trillion.

Anthoni Salim, the President Director and Chief Executive Officer of Indofood, said: “For the nine-month period this year, Indofood has been able to maintain positive performance, supported by its vertically integrated business model. We remain focused on driving organic growth, while balancing market share with profitability and maintaining a healthy balance sheet.”
