

Groundbreaking of Maynilad Water Treatment Plant held; Muntinlupa residents to have potable water soon

HAVING reliable potable water is a decades-old dream for Muntinlupa residents—one that will soon become a reality with the construction of Maynilad's Water Treatment Plant (WTP) facility in Putatan, Muntinlupa.

Ceremonial groundbreaking for the WTP project was held last February 6, 2009, and among those who attended the event were Atty. Byron San Pedro representing Muntinlupa mayor Aldrin San Pedro, Maynilad president Rogelio Singson, MWSS administrator Diosdado Allado, NIA administrator Carlos Salazar, DMCI Holdings, Inc. chairman David Consunji, Metro Pacific president Jose Ma. Lim, and Pall Corporation vice president Francis McKeever.

Simultaneously held with this event was the ceremonial turnover to MWSS of the NIA facilities, which will serve as the construction site for the new reservoir and WTP.

The new WTP facility will source its water from Laguna Lake, and water purification will be done through microfiltration and reverse osmosis. Pall Corporation, the global leader in filtration, separation, and purification solutions, will be the project's water treatment technology provider.

According to President Singson, the plant can produce 100 million liters per day (Mld.) of water once it becomes fully operational in 2010. Some 105,000 households in the southern part of the West Concession stand to benefit from the construction of this modern water treatment facility.

Meanwhile, Atty. San Pedro expressed the city mayor's enthusiasm and full support for the project. According to him, Mayor San Pedro looks forward to the completion of Maynilad's water treatment facility so the people in Muntinlupa can finally enjoy the benefits of reliable potable water.
